Mission Statement

CancerCare is a national nonprofit organization that provides free, professional support services to anyone affected by cancer: people with cancer, caregivers, children, loved ones and the bereaved. CancerCare programs - including counseling, education, financial assistance and practical help - are provided by trained oncology social workers and are offered completely free of charge. Founded in 1944, CancerCare now provides individual assistance to more than 91,000 people each year, and an additional 1.6 million people visit our websites, www.cancercare.org and www.lungcancer.org, to gain information and resources.

Letter From Our Executive Director and President

Dear Friends,

CancerCare has provided programs and services for individuals with cancer and their families for 61 years. Originally a local organization serving the New York tri-state area, today, CancerCare assists people across the country, and we are continually expanding our reach.

CancerCare's staff of professional oncology social workers help people develop strategies for coping with the medical, emotional and practical aspects of cancer. During the 2005-2006 fiscal year, our programs and services helped more people than ever. For instance, we:

- Provided individual counseling services to more than 30,000 people
- Gave a total of \$4.7 million in financial assistance to over 16,000 people affected by cancer
- Distributed nearly 1 million CancerCare publications to people with cancer, their loved ones and health care professionals
- Sent our monthly electronic newsletter, *CancerCare E-News*, to more than 34,000 people
- Provided nearly 35,000 people with the latest news about cancer research and treatments through our 46 Connect® Telephone Education Workshops
- Relaunched our website, www.cancercare.org, with a new and improved design that makes it easier for visitors to go straight to the information they need

Overall, CancerCare has provided direct assistance to over 91,000 people in 2005-2006. And that doesn't count the more than 1.6 million people who visit our websites each year to get the information and resources they need, when they need it most.

The number of people we serve with our free professional services continues to grow each year. We know there are so many more who can benefit from our assistance. We also know that it is only through the generosity of our donors that we can continue to expand our reach to meet the ever-pressing need for help and hope.

We thank you for your support and continuing dedication to our mission. Together, we really can make a difference in the lives of people facing cancer.

How CancerCare Extended Our Reach in 2005-2006

This year, CancerCare reached more people than ever before with our programs and services. We accomplished this through:

Help

- In 2005-2006, CancerCare provided financial assistance to people in all 50 states and in 81% of US counties. Our limited grants help individuals with cancer cover the costs of transportation, child care, home care and other expenses related to treatment, so they can focus on getting better.
- In 2005-2006, CancerCare distributed \$687,000 in financial assistance to 503 individuals with cancer and their families who were affected by the Gulf Coast hurricanes.



Education

- Our Connect® Telephone Education Workshops drew 34,994 participants to hear national experts in oncology speak about the latest treatment and coping information. Thousands more listened to past workshops on our website, or downloaded them for listening on their MP3 players.
- 34,416 people received our monthly electronic newsletter, *CancerCare E-News*, which provides updates on our programs and services. Subscriptions increased 67% over the previous year.
- We distributed 950,204 *CancerCare* publications to people with cancer, loved ones and health care professionals. Our materials include Connect® booklets, which are based on our Telephone Education Workshops; Inform® fact sheets, which offer practical tips for coping with cancer; and other helpful brochures and booklets.

Hope

- CancerCare's staff of professional oncology social workers provided individual counseling services to 30,433 people coping with the emotional and practical challenges of cancer.
- We offered 48 online support groups, each led by one of our professional oncology social workers, to individuals with cancer, their loved ones and caregivers, available to them 24 hours a day, seven days a week.
- In addition, we offered 28 telephone support groups that allowed people across the country the opportunity to interact with others in similar circumstances and share their experiences without having to leave home.

Extending Our Reach Online

In March 2006, CancerCare relaunched our website, www.cancercare.org, to make it easier for visitors to navigate their way straight to the information and support they need.

Our new website features three separate sections for:

- Individuals with cancer
- Loved ones and caregivers
- Health care professionals

By clicking on the appropriate section, visitors can get targeted information, including a list of frequently asked questions on how CancerCare can help.

Here's a sampling of the valuable resources available on our new website:

For individuals with cancer: A directory of CancerCare services by cancer type; information on face-to-face, telephone or online support groups for people with cancer; and free publications on the medical, emotional and practical aspects of cancer.

For loved ones: Information on CancerCare support groups for loved ones and caregivers; fact sheets with helpful advice on topics such as what to say to a person newly diagnosed with cancer and how caregivers can help themselves; and tips on finding financial assistance for their family.

For health care professionals: Information on how to refer patients to CancerCare's programs and services; an invitation to consult with our staff of professional oncology social workers on any patient concerns; and an online form for ordering free publications to distribute to patients.

By providing a forum for communicating directly with health care professionals, our new, upgraded website helps us reach more people with information about CancerCare. And, by tailoring content to each visitor's specific concerns, we can offer more comprehensive information about our programs and services.


I am a health care professional

Extending Our Reach in a Time of Need

CancerCare Distributes \$687,000 to People Affected by the Gulf Coast Hurricanes

When Hurricane Katrina devastated the Gulf Coast region in late August 2005, many area residents were confronted with trauma, uncertainty and the immediate need to relocate. For people with cancer and their loved ones, these challenges created practical and financial obstacles to getting necessary treatment and emotional support.

CancerCare has a long history of distributing financial assistance quickly and accurately to people affected by cancer. Because of our impressive record, the American Society of Clinical Oncology's ASCO Foundation chose our organization to oversee the disbursement of money raised for its Hurricane Relief Fund.

Other program supporters, including the Susan G. Komen Breast Cancer Foundation, Lance Armstrong Foundation, Asterisk Foundation and Amgen, contributed significant additional funds to CancerCare for distribution to Gulf Coast residents coping with cancer.

Thanks to these generous donors, CancerCare was able to provide immediate financial assistance to help patients cover costs, such as:

- Transportation
- Home care
- Lodging and other living costs
- Medicine for side effects
- Child care
- Medical equipment

In addition, our outreach efforts in the Gulf Coast region raised awareness of CancerCare's free professional support services, including counseling and education, among health care professionals in that area, which is helping us expand our services in that part of the country.

Many doctors and nurses who were not aware of the valuable services we could provide for their patients prior to the hurricanes are now actively involved with CancerCare. They regularly listen in to our Connect® Telephone Education Workshops, order publications for distribution to their patients and refer clients to us for help.

The Hurricane Relief Fund Helped People Like...

...Michael and Kerri, who received financial assistance to help with surgery and medications.

Just before the hurricane, Kerri had scheduled surgery to remove a vascular access port that doctors had used to deliver chemotherapy directly into her blood stream. Her plans were derailed by the hurricane.

In the aftermath of the storm, Kerri developed an infection at the site of the port, and Michael and Kerri needed help covering the cost of antibiotics. In the chaos left by the hurricane, they also had trouble finding a doctor to perform the operation. Fortunately, they learned about CancerCare and contacted us.

"We would like to really thank you and the rest of the staff for your efforts to assist us in this matter and for helping us financially during these trying times," says Michael. "We have never seen a team try so hard and dedicate so much time, energy and heart into a project for people that you don't even know. As Kerri's husband, I am relieved that the port is finally gone and she is happy because of it. Anything that makes my wife happy makes me happy as well!"

"On a more personal note, we would like to applaud and send our deepest gratitude to you, your coworkers and the people and companies that make organizations like CancerCare available to those that need the services," Michael continues. "Victims of natural disasters are really needing someone to lend a helping hand. You and the rest of the CancerCare team have not only done that, but you have also touched a special place in our hearts! Your work will never be forgotten."

...and Anna-Marie from Metairie, Louisiana, who received financial assistance to defer the costs of care and treatment.

Anna-Marie was an active, vibrant 19-year-old college student when she was diagnosed with Hodgkin's lymphoma and underwent chemotherapy. The treatments, says her mother Donna, were "not kind to her physically [or] mentally."

The costs of Anna-Marie's care also put a strain on the family finances. That's when Donna contacted CancerCare and found out about the Hurricane Relief Fund.

"With your help we were also able to purchase an 'age appropriate' wig, which was not covered under insurance and would not have otherwise been possible to purchase," says Donna. "This lifted her spirits considerably."

A year after the hurricane, Donna was rebuilding her home in Metairie and sharing better news with CancerCare. *"Anna-Marie's recent PET scan shows much improvement, and it is hoped that she will once again return to that active co-ed," she writes. "We so look forward to having our daughter's health return and our home [completely] restored. What a year it has been! Many thanks."*

In 2000, an initial \$2.1 million grant from the Avon Foundation helped CancerCare establish the AvonCares financial assistance program. Since then, Avon has contributed more than \$11.5 million to CancerCare. We've distributed \$9.1 million to 29,659 women with breast, cervical and ovarian cancers to help with cancer-related costs such as homecare, childcare and transportation. \$2.4 million from Avon has been applied to our Women's Cancers support services, which include individual counseling, support groups and other emotional and practical assistance. 

Unrestricted Revenue



Expense Ratio



Program Service Expense Ratio


