

Individual Counseling / Helplines

CancerCare's oncology social workers offer one-on-one emotional and practical support in English and Spanish to people living with cancer, post-treatment survivors, caregivers and the bereaved.



CancerCare Hopeline 800-813-HOPE (4673)

Our toll-free Hopeline, run by our oncology social workers and resource navigators, provides support to anyone affected by cancer in the United States. This year, we answered 45,577 calls through our Hopeline.



Triple Negative Breast Cancer Helpline 877-880-TNBC (8622)

In partnership with the Triple **Negative Breast Cancer** Foundation, this helpline provides free professional support to patients and caregivers coping with a TNBC diagnosis.



Bladder Cancer Helpline 833-ASK-4BCA or 833-275-4222

Our partnership with the Bladder Cancer Advocacy Network (BCAN) offers a dedicated helpline to support bladder cancer patients, their loved ones, caregivers and those who have lost a loved one to bladder cancer.

Resource Navigation

Cancer*Care* provides free resource navigation in English and Spanish over the phone to anyone in the United States, including U.S. territories, affected by cancer. This year, our staff provided **1,063 resource navigation sessions** to people diagnosed with cancer, caregivers, post-treatment survivors and the bereaved.



Financial Assistance and Co-Payment Assistance

The financial challenges of a cancer diagnosis and treatment can be overwhelming. Cancer*Care*'s financial assistance program helps with cancer-related costs, such as transportation, child care and co-payments. This year, we provided **\$53.8 million** in financial and co-payment assistance to **4,944 people**.



Support Groups (Online/Live)

People affected by cancer find a safe space to connect with others who relate to their experiences in Cancer*Care*'s free support groups, offered over a secure message board platform moderated by an oncology social worker, virtually over a video platform and through in-person groups. This year, **we hosted 64 support groups** in English and Spanish for people living with cancer, post-treatment survivors, caregivers and the bereaved. Educational Resources

Cancer*Care*'s **Connect**® **Education Workshops** offer a free and accessible way to learn about cancer-related issues from leaders in oncology. These one-hour workshops offer the latest information on topics relevant to the cancer community, such as treatment options, clinical trials and much more. We offered **63 workshops** this year, led by **133 experts** and supported by **69 partner organizations**, drawing **36,108 participants**.



Publications

Cancer*Care*'s library of fact sheets and booklets provide expert insight into a wide variety of cancer-related topics. Publications can be read online, with select titles available free in print. This year, we distributed **676,302 print and digital publications** to people affected by cancer and to health care professionals.



Website

Cancer*Care*'s free resources and programs are easily accessible through our website (**www.cancercare.org**).



Online Helping Hand

Our Online Helping Hand provides an extensive, up-to-date database of resources and services for people affected by cancer. Users can find hundreds of national and regional organizations, searchable by zip code and types of assistance needed. This year, users completed **87,146 searches** through our digital resource database.

Back-to-School Program

Getting new school supplies can be especially challenging for families coping with a cancer diagnosis. Cancer*Care*'s **Back-to-School Program** addresses this challenge by providing new backpacks full of age-appropriate school supplies for students affected by cancer in pre-K through 12th grade throughout the tri-state area. This year, free packages were sent to **223 students** from **98 families**.

Winter Programs (Winter Warmth, Holiday Gift Cards)

For children and teens affected by cancer, the **Winter Warmth Program** provides warm winter accessories, while the **Holiday Gift Card Program** provides gift cards. These programs bring comfort and relief while easing the financial strain experienced by families affected by cancer. This year, **137 children and teens** received winter accessories and **149 children and teens** received gift cards.

Healing Hearts

Last June, Cancer*Care* hosted its **15th Annual Healing Hearts Family Bereavement Camp**, a free retreat for families and children coping with the loss of a loved one to cancer, at Memorytown USA in Mount Pocono, Pennsylvania.

Cancer Screening

The **Time to Screen** campaign, created by Cancer*Care* in partnership with Community Oncology Alliance, encourages adults to take charge of their health by getting recommended cancer screenings. Time to Screen features educational resources on its website (**www.timetoscreen.org**) and a toll-free hotline at **1-855-53-SCREEN (1-855-537-2733)**, which helps find local screening options.

Community Programs



MY CANCER CIRCLE

My Cancer Circle allows people living with cancer and their caregivers to manage day-to-day care and stay in touch with loved ones. Users can form a private online community with family, friends and neighbors to share updates, send reminders and organize specific tasks. This year, 42,440 users participated in 1,976 active caregiver communities.



LEGAL CLINIC

Cancer*Care* has partnered with LegalHealth, a division of the New York Legal Assistance Group (NYLAG), to provide **free legal clinics**, funded in part by AbbVie Pharmaceuticals, for individuals in New York City living with cancer, caregivers and the bereaved who are facing cancer-related legal concerns.



Young Professionals Committee

YPC SCHOLARSHIPS

For the fifth award cycle, Cancer*Care*'s Young Professionals Committee (YPC) Scholarship Program provided one-time \$2,500 scholarships to young adult students enrolled or are seeking to enroll in four- or six-year accredited undergraduate colleges in the U.S. who have lost a parent or guardian to cancer. Since its start, this program has awarded **\$10,000 in scholarships**, making a positive difference for these young adults.

Coping Circle Workshops

Cancer*Care* offers free virtual **Coping Circle Workshops** for anyone affected by cancer. Facilitated by oncology social workers, these workshops offer practical guidance and emotional support to better cope with a cancer diagnosis. **Workshops in fiscal year 2024 included:**

Cancer Out Loud

This award-winning Cancer*Care* podcast features conversations with people diagnosed with cancer, caregivers, post-treatment survivors and bereaved individuals. Each episode sheds light on the importance of a support network, coping techniques, self-advocacy, navigating grief and more. This year, **ten full-length episodes** were released.



Pet Assistance & Wellness (PAW) Program

Cancer*Care*'s PAW Program offers educational resources for dog and cat owners in active treatment and financial assistance to offset the cost of pet food, veterinary bills, pet caregiving services and more. In 2024, we released Helping Paws, a searchable online database of free or low-cost pet care services. This year, **we helped 991 people** with cancer keep their pets at home.

Specialized Programs

Young Adult Programs

Cancer*Care* addresses the unique challenges that young adults aged 18-40 affected by cancer face through **virtual and in-person programs**. These include live and online support groups, workshops on a variety of topics and community programs where participants can connect with others navigating similar experiences.

Older Adult Program

Cancer*Care* helps build connections and reduces isolation for older adults affected by cancer. Our programs include a live virtual support group in NY and NJ, virtual book and movie clubs and an in-person paint & sip class. This year, we also **provided new coats** to **75 individuals** aged 50+ in active treatment through our Share the Warmth Program.

Wig/Prosthesis Clinics

Cancer*Care*'s in-person and virtual Wig Clinics offer opportunities for women with treatment-related hair loss to receive free wigs in various colors, lengths, styles and textures alongside a professional wig fitter. Our Breast Prosthesis Clinics help women who have had a breast cancer-related mastectomy try on mastectomy bras and breast prostheses with help from a trained fitter while providing free mastectomy supplies. This year, we distributed **841 total wigs and prostheses**.

Caregiver Program

People caring for a loved one with cancer receive specific services and resources as well as space to process their emotions while connecting with others in similar situations. Our programs for caregivers this year included **live and online support groups, virtual workshops and in-person events**.

LGBTQ+ Program

For LGBTQ+ individuals affected by cancer, Cancer*Care* provides **emotional and practical support**, including safe and affirming online support groups for patients and caregivers, virtual educational workshops and easy-toread publications.

Breast & Gynecological Cancers Program

Cancer*Care* offers specialized services and resources for people diagnosed with breast and gynecologic cancers and their loved ones, including live and online support groups, virtual workshops and events.

Education, Awareness & Advocacy on the Dangers of Alternative Funding Programs

Cancer*Care* continues to address the barriers to care caused by Alternative Funding Programs (AFPs), which are ways for employers to control access to specialty medicines for their employees. Under Cancer*Care*'s leadership, the AFP Task Force includes twenty-seven like-minded organizations who join monthly calls to educate, coordinate outreach opportunities, identify and collect patient stories and strategize next steps to protect patients from the harms caused by AFPs.

Elevating Patients' Needs, Priorities & Perspectives Through Policy

Cancer*Care* plays an integral role in ensuring that federal and state health policy discussions and proposed solutions prioritize patients' access to timely, affordable and equitable care and treatments. The many issues we address include ensuring patients with rare cancers continue to benefit from innovative treatments, the six protected classes of drugs within Medicare Part D remain strong, patients have timely access to comprehensive biomarker testing, elevating awareness of financial toxicity and the importance of patient assistance programs and that all cancer patients receive the most appropriate and innovative care and treatment, including meaningful access to clinical trials.

CARE Survey to Explore Impact of Health Insurance Practices on Patients

In continued efforts to support access and affordability of cancer care, Cancer*Care* announced the **CARE Study** (**C**ommercial Insurance and Pharmacy Benefit Manager Impact on **A**ccess and Quality of Life: A **R**esearch **E**valuation Among People with Cancer). This multi-sponsor national survey seeks to better understand how utilization management (UM) strategies affect patients' real-world experiences and impact their care access, finances and well-being. UM strategies are used by insurance plans and pharmacy benefit managers to reduce costs and improve outcomes, but for patients, these tactics can lead to reduced or delayed access to essential care, increased patient costs and reduced quality of life. Insights from CARE will guide patient-focused advocacy and education and shape future health care policy.

In honor of the organization's 80th anniversary, Cancer*Care* received an official New York City mayoral proclamation and May 4, 2024 was declared "**Cancer***Care* **Day**." "When my daughter died in 1986, I went to a CancerCare support group. It was only for people who had lost a child to cancer, which I think was good for all of us, because it's different for different losses.

When my husband was diagnosed with stage four cancer three years ago, I found it helpful. I'm still friendly with the people from 1986 and now I have three good friends from this support group."

Get The Facts

Cancer*Care* continued to offer its series of educational videos, available in English and Spanish, as part of its "**Get the Facts**" campaign. These videos cover topics important to patients and caregivers, including managing a loved one's diagnosis, cultural humility, understanding who is on a cancer caregiving team, CAR T-cell therapy for multiple myeloma and CAR T-cell therapy for cancers of the blood and lymph tissues.



myTRIAList

In 2023, Cancer*Care* launched **myTRIAList** (www.mytrialist.org), a clinical trial resource website, to simplify the clinical trial search process and break down barriers to enrollment.



Financial Summary

In our fiscal year ending June 30, 2024:

- CancerCare provided 163,917 services to people affected by cancer, serving clients with 100 different types of cancer in all 50 states and 2 U.S. territories.
- Our oncology social workers answered 45,577 calls to our helplines.
- Our staff provided 90,818 hours of emotional and practical support through our Hopeline, individual counseling, support groups, community programs, resource navigation and more.
- CancerCare provided financial and co-payment assistance to **25,246 people** for costs including transportation, practical needs and to pay for cancer medications.
- Cancer*Care* welcomed **2.5** million visits to our websites, and users completed **87,146** searches in our Online Helping Hand to find practical and financial assistance.
- We distributed **676,302** print and digital publications to people living with cancer, caregivers, loved ones and health care professionals with over 300 titles in our library.
- Leading experts in oncology led 63 CancerCare Connect[®] Education Workshops, from 133 faculty members and 69 partner organizations, drawing 36,108 participants.
- The Pet Assistance & Wellness (PAW) Program helped **991 clients** keep their pet in the home.
- My Cancer Circle[™] served **42,440 active users** in **1,976 active caregiver communities**.
